Summary of findings

Overall summary

Quebec Hall is a residential care home and was providing accommodation and personal care to 20 people at the time of the inspection. The service can support up to 22 adults.

Quebec Hall accommodates people in a large listed building. There are spacious grounds for people to enjoy which also contain a number of sheltered bungalows which do not form part of the provider's current registration.

We found the following examples of good practice.

Due to COVID-19, external religious speakers had been unable to conduct Christian meetings within the service. A person who received support had taken this duty upon themselves and had conducted these services to their fellow house mates. This ensured the spiritual needs of the individuals had been continued.

Staff were observed wearing Personal Protective Equipment (PPE) in line with current government guidance. PPE was doffed within each individuals bedroom following support and disposed of appropriately to reduce the risk of cross contamination.

All people who had chosen to have the COVID-19 vaccination had done so, ensuring their mental capacity had been assessed prior to this process.

Robust risk assessments had been completed for both the people supported and the staff team. This ensured that all known risks had been assessed in relation to COVID-19 on a personal basis.

All areas within the service were clean and clear from clutter. Cleaning records reviewed evidenced regular cleaning of all areas, including higher risk touch points.

Detailed findings

Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

As part of CQC's response to the coronavirus pandemic we are looking at the preparedness of care homes in relation to infection prevention and control. This was a targeted inspection looking at the infection control and prevention measures the provider has in place.

This inspection took place on 09 February 2021 and was announced.
